General Conditions

Deposit Requirements: A Deposit of \$200.00 per person (deposits are non refundable) is required to reserve your category. The balance is before departure (October 5, 2005). Payment can be made by money orders, pay pal or credit cards (make money orders payable to BVSG and attached to this form and mail to the address below).Cabin number will be assigned when full payment is received, additional details regarding cruise will be sent at that time.

Cancellations and Refunds: All cancellation requests must be addressed to Healing into Wholeness Tours in writing.

Cancellation fees will be charged as follows:

- 75% per person administrative fee when cancelled more than 60 days before sailing.
- 25% of cruise fare when cancelled 60-30 days before sailing.
- 50% of cruise fare when cancelled 29-15 days before sailing.
- No refund refund for no shows or when cancelled within 14 days before sailing.

Airline ticket cancellation is subject to the cancellation policy of the specific airline. In most cases tickets are non-refundable. Trip cancellation insurance is recommended. A cancellation Waiver from HIW tour will be offered with the confirmation of your booking.

Embarkation: The Fascination sails from Miami, Fl at 4:00PM on Friday, December 9, 2005. Embarkation begins at 12:30PM. You must be on board no later than one-half hour before sailing (please Schedule Flights to arrive to Miami Airport no later than 12pm).

Disembarkation: The Fascination returns to Miami at 8:00AM on Monday, December 12, 2005. Allow 2 -3 hours for disembarkation, customs and immigration formalities (please allow 3 hours to get thru customs when booking ALL return airline arrangements)

Passage Contract: The attention of the passengers is specially directed to conditions of transportation set forth in the passage contract of the ticket of Carnival Cruise Line General Sales Agents and Operators.

Immigration: U.S. and Canadian citizens must carry a valid passport as documentary proof of citizenship. A Social Security card is not acceptable as proof of citizenship. Aliens who are permanent residents must have their Alien Registration Card and

passport. All other non -US passengers should contact their respective embassies of U S immigrant ions for applicable regulations.

Accommodations: Prices are from Miami, Fl based on two full paying passengers per cabin.

Fare inclusive: Cruise packages are Private and Exclusive to this Group only... individuals making reservations made outside of travel agency provided by the Wholistic Sea Summit Cruise (WSS) will not be allowed in ANY Private WSS programs.

The Wholistic Sea Summit is an all inclusive cruise experience excluding air travel and ground transportation. Price includes cruise, taxes, government fees, port charges, insurance, gratuities, food (including 24 hour room service) workshops, all Wholistic Sea Summit private activities.

It does not include private coaching or consultation sessions or shore exclusions which are optional, nor air travel or ground transportation.

You must booked your cruise thru Healing into Wholeness Tours in order to participate in WSS programs.

Ship's Doctor: The doctor will make customary charges for treating passengers at their request.
